**BREACH OF PLANNING CONDITION – ANGLOS PIZZA, 236 DURHAM ROAD, GATESHEAD, TYNE AND WEAR
APPLICATION NO. 215/73 USE OF SHOP PREMISES (CHINESE CARRY OUT MEALS) AS A FISH AND CHIP SHOP**

Condition No 2. of the above planning approval granted on 7th June 1973, (Ref: 215/73) states that *"The premises shall not remain open any later than 11pm."*

Complaints have been received that the premises are regularly open for business past 11pm, causing noise and disturbance.

An enforcement officer from this Department has visited the premises and observed the business to be trading after 11pm.

Having regard to the circumstances your actions are considered to amount to a blatant breach of planning control.

In order to rectify the situation I attach by way of service a Breach of Condition Notice against which there is no right of appeal. Your attention is drawn to the warning set out in the annex to the notice and the penalties for failure to comply. My officers will continue to monitor the operation of the premises following the expiry of the period for compliance with the notice when the necessity for further action will be assessed.

- 1. THIS NOTICE** is served by the Council, under section 187A of the above Act, because they consider that a condition imposed on a grant of planning permission, relating to the land described in paragraph 2 below, has not been complied with. The Council consider that you should be required to comply with the condition specified in this notice. The Annex at the end of this notice contains important additional information.
- 2. THE LAND TO WHICH THE NOTICE RELATES**

236 Durham Road, Gateshead, Tyne and Wear, NE8 4JR, shown edged red on the attached plan.
- 3. THE RELEVANT PLANNING PERMISSION**

The relevant planning permission to which this notice relates is the permission granted by the County Borough of Gateshead on 7th June, 1973, Reference No. 215/73, for the Use of shop premises (Chinese Carry-Out Meals) as a Fish and Chip shop.
- 4. THE BREACH OF CONDITION**

The following condition has not been complied with:

Condition No. 2
The premises shall not remain open any later than 11pm.

5. WHAT YOU ARE REQUIRED TO DO

As the person responsible for the breach of condition specified in paragraph 4 of this notice, you are required to comply with the stated condition by taking the following steps: -

- (1) Close the premises at 11pm every day.

Period for compliance: -

- (1) 28 days beginning with the day on which this notice is served on you.

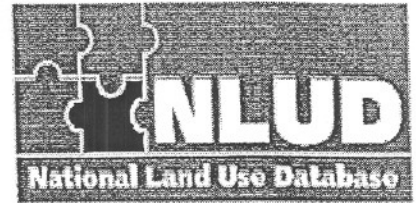

It is an offence to contravene the requirements stated in paragraph 5 of this notice after the end of the compliance period. You will then be at risk of immediate prosecution in the Magistrates' Court, for which the maximum penalty is £1,000 for a first offence and for any subsequent offence. If you do need independent advice about this notice, you are advised to contact urgently a lawyer, planning consultant or other professional adviser specialising in planning matters. If you wish to contest the validity of the notice, you may only do so by an application to the High Court for judicial review.
