Your right to information

A brief guide to your right of access to council information under the **Freedom of Information Act 2000**



Your right to access council information

This leaflet explains your right to access information held by Gateshead Council under the Freedom of Information Act 2000. It explains briefly what the Act covers and what you should do if you want to see any information held by us.

Please note. The information available to you under the Freedom of Information Act is not personal information. Access to personal information held about you by the council is covered by the Data Protection Act. A separate leaflet setting out your rights under this Act is available by contacting the number on the opposite page.

What rights does the Freedom of Information Act give me?

From 1 January 2005 you have a right to see, or have a copy of, most written information held by the council.

But you should note that:

- Some types of information do not have to be released
- · You may have to pay a fee

How do I make a request?

Put your request in writing (or fax/email) to the council including your name, address and telephone number.

You can also use the council's Freedom of Information request form - available on the internet: www.gateshead.gov.uk and from local council offices.

We must reply to you, normally within 20 working days, saying whether or not we have the information you want. If we do, we must supply you with a copy of it, or a summary of it, or we must make it available for you to inspect.

Will I be charged?

Yes, you will be charged for photocopying and other disbursements such as postage and packing, plus vat, I it would cost us more than £10.





Do I need to go through this procedure just to get simple information?

No . A lot of information is available on our website, on information leaflets and other publications, as well as via telephone enquiries. The Act gives you extra rights by allowing you to see or have copies of information which might not otherwise be published - unless an exemption applies.

Is there any information which I am not allowed to have?

Yes, some information is not available such as:

- Information about investigation of crime.
- Court records.
- Information about commercial interests.
- Personal information about other people.

If we think you are not entitled to see the information you have asked for, we will write and explain why.

What if I'm not happy that you've refused to let me have the information

You have a righjt of appeal to the council. You should write to the Strategic Director of Legal and Corporate Services within three weeks of receiving it. You will be informed of the appeal decision in writing.

If you are still unhappy you can contact the Information Commissioner - details below.
